Juan M. Kivotos, 12023 - 12025 Orange Street, located between Clarkdale Avenue and Funston Avenue on the north side of the street (also known as APNs 8056-028-019 and 8056-028-020); a request to construct a new 5-unit condominium complex.

**Staff Recommendation:** That the Planning Commission:

- (1) Adopt Resolution No. 14-18 to approve Tentative Tract Map No. 72091, subject to the conditions of approval contained in respective Exhibit "A"; and
- (2) Adopt Resolution No. 14-19 to approve Precise Development Plan No. 1911 subject to the conditions of approval contained in respective Exhibit "A".

**3. APPEAL OF ANIMAL PERMIT NO. 11-67**

Rene Cortez; 11908 East 161<sup>st</sup> Street (located on the south side of 161<sup>st</sup> Street, approximately 100-feet east of the intersection 161<sup>st</sup> Street and Clarkdale Avenue); an appeal of staff's decision to allow up to a maximum of twenty-five (25) pigeons instead of one-hundred (100) to one-hundred and fifty (150) pigeons at a single-family residence as requested by the applicant.

**Staff Recommendation:** That the Planning Commission receive and file this request as the applicant is requesting to withdraw his appeal of Animal Permit No. 11-67.
